

PRESIDENT'S REPORT



Greetings,

Charleston, SC was a wonderful location for the 36th reunion. It was great to see so many of you once again. I was a little worried about the possibility of a hurricane, but it stayed at sea and didn't affect the South Carolina coast. The weather was nice and it appeared that everyone had a good time. Charleston is a beautiful and historic city. At the general meeting, the members in attendance voted to hold the 2025 reunion in San Antonio, TX., with Branson, MO as a backup location. The organization has previously held a reunion in each of these cities, San Antonio in 2006 and Branson in 2001.

This year is Mike Schappaugh's last as Storekeeper for our Ships Store. Mike started as storekeeper in September 2016. In the past 7 years he has taken the store to a new level. The product line offers something for everyone. If you've been to any of our reunions, you know what I mean. We typically need eight to ten 8' tables to display all the items he brings. Mike has taken the store inventory home to Florida and will not be bringing it back to the reunion in Cherry Hill! We will either have to arrange for someone to pick it up, or we'll have to have it shipped. Mike has officially resigned, actually he submitted his resignation letter over a year ago. We presented him with his "Appreciation" plaque at this year's banquet. We are in serious need of a new storekeeper. If you are interested in helping out the organization, please contact me. My contact information is on the officers page at the beginning of this issue.

The 2024 reunion hotel is scheduled to be the DoubleTree Hotel in Cherry Hill. When we contracted with the hotel, we were told it would be undergoing renovations and they would be done by the time we held our 2024 reunion. Prior to the 2023 reunion, Dave called the hotel sales staff to find out how the renovations were progressing. At the Board meeting, Dave reported that the renovations were substantially behind schedule, and they could not guarantee that they would be completed by the start of our reunion. This was obviously concerning to all. On our way back to NH, Judy and I stopped at the DoubleTree. We met Steve Sheehan at the hotel, where we talked with the sales staff. There is currently one floor of guest rooms completed and a second floor is almost finished. They have a new general contractor and are now shutting down one floor at a time to complete the guest room renovations per floor. As with all construction projects, lack of materials, due to supply chain issues, is a constant problem. On a positive note, as part of the overall

renovations, all 400+ guest rooms have received new beds, mattresses and linens. All the rooms with 2 beds now have queen beds in place of the double beds. During our 2022 reunion, there was a problem with the air conditioning in our hospitality/ship storerooms (Plaza Rooms I, II & III). These rooms now have new A/C equipment installed. Although they can't make any promises, they are hopeful that a majority of the renovations will be completed by next September. There is nothing in our contract that allows us to cancel because the renovations are not complete, without incurring a financial penalty. Canceling now would result in our organization having to pay liquidated damages in the amount of \$32,977.50. We obviously can't afford that, so all we can do is have faith that the DoubleTree will be working hard to get the renovations completed as soon as possible. It's also obvious that the completion of the renovations is in the best interest of the hotel and that they want them to be completed as much as we do. There will be an update in the 2024 Spring issue.

The minutes of the past business meeting were published in 2022 Fall issue of the Bounce. A motion was made to dispense with the reading of those minutes was made by Tim Flynn and seconded by Steve Sheehan. Motion carried.

Treasurer Report: Phil Tasker reported that 2022 financials were included in the Spring Bounce and provided a summary of those numbers. He stated that he would be glad to entertain any questions the membership might have. There being none, he said that the organization currently had total cash funds of \$58,559.65 which included restricted Funds of \$14,199.50 (Restricted Funds are those monies set aside For Scholarship, Ships restoration etc.) Leaving available funds of \$44,360.15. Phil is estimating that approximately \$12,000.00 will come out of available funds to complete paying for this reunion. Ray Kehoe moved to accept the Treasurer's Report which was seconded by Marvin Williams. Motion carried.

Membership Report: Chuck Oehme reported that we currently have 401 last year we had 439 members. 10 are WWII members, 76 Korean era members, 154 Vietnam members, 102 80's members and 57 Associate members. We have 13 new members and 4 are at this reunion. A general discussion was held on how to increase membership. Motion to accept by Joe DiMaria seconded by Tim Flynn. Motion carried.

VA Report: Joe DiMaria explained that not much has changed in the past year, this is not in a negative way just on current updates. If not using VA, you should at least sign up to get things in motion. Joe brought up the Camp Lejeune lawsuit that is currently going on. Be careful when dealing with Attorney's in this case. You can be awarded money but can put VA Benefits on hold until that money has been recovered then VA Benefits would pick back up. Make use of benefits they can provide you with glasses, hearing aids and very good price on prescription drugs. Joe did inform that all the states have a VA location and will work with you, you just have to get the process started. General discussion and comments from the floor. Motion to accept by Steve Sheehan 2nd by Marvin Williams. Motion carried.

Reunion Coordinator's Report: Dave Wasmer reported that This reunion has gone well and coming to an end at the Banquet tonight. The 2024 reunion will be back at the ship; however, the Double Tree Hotel is under renovation, Dave talked to Dawn the hotel manager earlier this week and she informed him that the renovations will probably not be complete by the reunion. By cancelling this contract, we could possibly be out a lot of money, Bob Dingman said he will check with other hotels this is really up in the air right now. The tours we would have taken in 2020 to Ground Zero and 911 Museum would have been \$100.00 per person it is now \$150.00 per person. The tour to Constitution Hall and USS Mint would have been \$80.00 per person and now over \$100.00 per person. The buses to and from ship have gone up by \$500.00 and that is with the same company. Dave asked in general what was too much per person for tours. Currently there are no tours set up for next year. General discussion from the floor. Dave made note that the plaques in ship store that he is making he will make for any members just fill out a form he will make you one, the cost is \$25.00 and that includes shipping. Motion to accept by Steve Sheehan 2nd by Joe Cusumono. Motion carried.

Small Stores: Mike Schappaugh reported that the store is selling things and that sales are good. Mike really wanted to stress that he needs someone to take over this position. He said if nobody takes over by next reunion he will not be bringing items back. Motion to accept made by Tim Flynn with second by Joe Cusumono. Motion carried.

REUNION REGISTRATION FEES

During the 2023 Business Meeting held in Charleston, South Carolina in conjunction with our 35th Reunion there was significant discussion held about the losses incurred in hosting our annual reunions. After those discussions the attendees voted unanimously to introduce a registration or participation fee to help reduce future deficiencies.

Our losses over the past five reunions held (not including 2023 as final numbers were not available at the time of this writing but will continue to be significant) have totaled \$14,323, an average of \$2,865 a year:

When pricing events at each reunion the Reunion Coordinator has traditionally looked at unit costs of the event and marked up the unit cost modestly to contribute to overhead. The theory being the attendees of an event should cover the cost of the specific event.

However, there are a number of costs associated with the Reunion that are not event specific. First, we have Reunion Planning. To have a successful reunion it is essential that that Reunion Committee preliminarily visits the venue, and reviews lodging facilities, tour opportunities and transportation sources. We do not want any surprises either financially or with the quality of the services. Reunion Committees have made preliminary site visits the year before a scheduled Reunion for at least the previous twenty years. Yet the costs of these site visits do not normally get factored into event costs.

A second unrecovered cost is the hospitality room. We have always had a venue hotel area dedicated to our Reunion attendees where members could meet and socialize. The hospitality room has always been well stocked with coffee, soft drinks, bottled water, and gedunks. The cost of stocking the hospitality room has also not been factored into individual event pricing.

The \$20 per person Participation Fee was proposed as a means of trying to cover some of these extraneous costs and reduce the burden on non-attendee membership fees.

State of the Museum Report

Shipmates,

I regret not being able to attend the crew reunion in September. It fell on the same week as the annual Historic Naval Ships Association conference. 2023 has been a busy year for the museum. We have moved forward with major restoration projects, like redecking the ship, and preparing for dry-dock. We have seen a boost in our visitation numbers, especially over our pandemic numbers but even over some of our best pre-pandemic years. We have also found new artifacts of the ship, that had been hidden on board for decades.

2023 is set to be the best year for the museum in the last decade. Throughout the year our visitation numbers have been neck and neck with 2019, the museum's previous best year. Over the winter we were as much as 20% ahead of 2019's visitation up to the same date, but during the summer we occasionally fell below 2019's numbers. As we move into the fall, our numbers are higher once again. This shows that our move to being open all 12 months out of the year instead of being closed over winter is bearing fruit. Not only are the numbers going up, but the visitation is being spread out over the whole year instead of overwhelming us for a couple of months over the summer.

2024's visitation will likely be lower due to some closures; however, we are expecting big numbers in 2025 and 2026. The closures will be the result of dry-docking the ship, more information on that below. 2025 is the 250th anniversary of the founding of the Navy and Marine Corps which happened in Philadelphia in October and November 1775, respectively. This year the city is hosting, and we are participating in, the first ever combined Navy and Marine Corps week from October 9-15. This will be a dry run for the much larger celebrations happening in two years. The battleship will be a centerpiece of these celebrations.

We are still working on getting a date for when the ship will be in the yard, but it will likely be for two months, maybe as early as this winter. The approximate dates may already be released by the time this is published so be sure to check the museum's website and various social media accounts. We are posting updates on dry-dock every Wednesday night at 7pm EST on the YouTube channel. We will be putting the ship back in Dry-Dock 3 at the

former Philadelphia Navy Yard. This is where the ship had her rudders and propellors fitted when she was being built and where she was reactivated for the Vietnam War, so it is an entirely fitting location for her to receive her first yard period as a museum ship.

We plan on only doing work in the yard that can't be easily done pier side. This will include the big three projects of painting, sealing through-hull openings, and replacing anodes. For painting we will be giving her a "shave and a haircut": blasting and painting from the waterline down. We will be inspecting the 158 through hull openings including repacking the stern tubes for the propellors and patching the discharge from number two main condenser that was temporarily repaired about seven years ago. For the 1,204 23# zinc anodes bolted to the hull, our dive survey reported little deterioration because the zincs are less effective in freshwater like the ship's current berth, so we will be replacing these with aluminum anodes. This roughly \$10 million project will make sure that the ship is with us for many years to come. The state of New Jersey generously supported the project with \$5 million but there is still a long way to go for fundraising for this project.

Before dry-docking the ship, we will likely complete redecking the main deck of the ship. The fantail and both the port and starboard sides have been completed up to the turn in the superstructure. Over the summer our maintenance team started from the bow and completed everything forward of the breakwater. They are currently working on the port sides of turrets one and two before transitioning to the starboard side where the gangway is. There will still be some much smaller areas of the superstructure to redeck next year, but we are excited to be this far along in the project.

The coolest finds we have made in terms of artifacts related to the ship are more original keys and an 80's flag. Last time I mentioned that we had found about 20 pounds of weapons and engineering department keys in a box, including the various missile launch keys and keys to the reduction gears. The two boxes we just found seem to be more supply department keys, but we have not had a chance to go through them all yet. The flag is huge, made of nylon, probably constructed on board in the sail locker, and is bright yellow. It reads "Firepower for Freedom Battleship New Jersey BB-62 WETSU". WETSU was Captain, later Admiral Tucker's favorite slogan so we can date the flag pretty conclusively to 1990, just before the ship was decommissioned.

Finally, the Secretary of the Navy just announced the new USS *New Jersey*, SSN-796 will be commissioned on April 6, 2024 at Naval Weapons Station Earle, New Jersey. The crew of 796 has been regularly visiting the battleship and the museum's staff frequently remind the crew that the battleship and her crew are their heritage, but the submariners are this ship's legacy, and one day they will join us at these New Jersey reunions. If you want to stay up to date on what is happening at the museum be sure to check out

Did you serve on the USS New Jersey during the 1980's?

Paul Stillwell is an independent historian and retired naval officer. 




















USS Yorktown CV-5



We just completed our 36th Reunion in Charleston South Carolina. Our Memorial Service was held on the USS Yorktown (CV-10) which was named in honor of an earlier ship that was sunk during the Battle of Midway in World War II.

USS *Yorktown* (CV-5), commissioned in 1937 was the lead ship of the Yorktown class, which was designed on the basis of lessons learned from operations with the converted battlecruisers of the Lexington class and the smaller purpose-built USS Ranger.

Yorktown was at port in Norfolk during the attack on Pearl Harbor, having just completed a patrol of the Atlantic Ocean. She then sailed to San Diego in late December 1941 and was incorporated as the flagship of Task Force 17. Together with the carrier Lexington, she successfully attacked Japanese shipping off the east coast of New Guinea in early March 1942. Her aircraft sank or damaged several warships supporting the invasion of Tulagi in early May. Yorktown rendezvoused with Lexington in the Coral Sea and attempted to stop the invasion of Port Moresby, Papua New Guinea. They sank the light aircraft carrier Shōhō on 7 May during the Battle of the Coral Sea, but did not encounter the main Japanese force of the carriers Shōkaku and Zuikaku until the next day. Aircraft from Lexington and Yorktown badly damaged Shōkaku, but the Japanese aircraft critically damaged Lexington (which was later scuttled), and damaged Yorktown.

Despite the damage suffered, Yorktown was able to return to Hawaii. Although estimates were that the damage would take two weeks to repair, Yorktown put to sea only 72 hours after entering drydock at Pearl Harbor, which meant that she was available for the next confrontation with the Japanese. *Yorktown* played an important part in the Battle of Midway in early June. *Yorktown*'s aircraft played crucial roles in sinking two Japanese fleet carriers. *Yorktown* also absorbed both Japanese aerial counterattacks at Midway which otherwise would have been directed at the carriers USS *Enterprise* and *Hornet*.^[2] On 4 June, during the Battle of Midway, Japanese aircraft crippled *Yorktown*. She lost all power and developed a 23-degree list to port. Salvage efforts on *Yorktown* were encouraging, and she was taken in tow by USS *Vireo*. In the late afternoon of 6 June, the Japanese submarine *I-168* fired a salvo of torpedoes, two of which struck *Yorktown*, and a third sinking the destroyer USS *Hammann*, which had been providing auxiliary power to *Yorktown*. With further salvage efforts deemed hopeless, the remaining repair crews were evacuated from *Yorktown*, which sank on the morning of 7 June.

Greetings NEW JERSEY Veterans,

I thank you for your service and support of USS NEW JERSEY (BB-62) as it continues to bring rich history to every person that steps onboard!

I am writing to you to provide a short update on the final delivery stages of the newest Virginia-Class Submarine, USS NEW JERSEY (SSN 796). The major construction milestones are all complete and testing is in the final stages to support getting underway in the coming weeks. Our crew has completed several rigorous certifications over the last couple of months validating our readiness to conduct sea-trials. The team has ongoing training in the simulators that allow us to operate navigation, sonar, and depth control systems as if the ship were alive at-sea. We are also operating the shipboard systems to validate all equipment functions as designed before we cast off lines. And as with any ship, we are also focusing the crew on emergency responses and how to work as a team to combat fires, flooding, and other damage control situations. Overall, the team has impressed me with their eagerness to learn their watch-station and improve their ability to operate one of the most complicated vessels ever constructed.

Our sea trials will likely occur in the December/January timeframe to support our scheduled commissioning on April 6th, 2024 in Belford, New Jersey at Weapons Station Earle. The USS New Jersey Commissioning Committee is in full planning mode to make our event the "best commissioning ever". My crew has had many opportunities to visit the state of New Jersey, tour BB-62, and meet some members of NEW JERSEY Veterans group. All the Sailors that experienced this ship have been overwhelmed by the Black Dragon's impressive size and history that is embedded in every magazine and passageway. We look forward to keeping the BB-62 and SSN-796 connection strong to ensure we prolong Navy customs and traditions. We recently revamped our Submarine's battle cry to match the battleship and we will often adjourn our meetings with a strong "FIREPOWER FOR FREEDOM"!
